

**ORDINANCE OF THE MENDOCINO CITY COMMUNITY SERVICES DISTRICT 2020-03**  
**TO SET FEES AND CHARGES FOR FISCAL YEAR 2020-2021 AND THEREAFTER UNLESS AND**  
**UNTIL SUBSEQUENTLY REVISED OR CHANGED**

**WHEREAS**, the Mendocino City Community Services District (MCCSD) desires to provide a single and convenient location for a list of all fees and charges adopted by the District; and

**WHEREAS**, the fees and charges by the MCCSD are reviewed and revised in accordance with the adoption of the Fiscal Year Budget; and

**WHEREAS**, the fees in the attached Exhibit 1 list MCCSD fees and charges; and

**WHEREAS**, the Fee Schedule in Exhibit 1 attached and incorporated as part of this Ordinance shall repeal and replace all existing fees and charges in conflict with the Fee Schedule.

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE BOARD OF DIRECTORS** that the fee and charge amounts included in the attached Exhibit 1 — Fee Schedule – shall be adopted by the Mendocino City Community Services District, and the amounts set forth therein shall supersede the corresponding fee amounts prescribed in the District’s ordinances and resolutions.

**AND BE IT FURTHER ORDAINED AND ENACTED** that this Ordinance shall be published once in the Mendocino Beacon, a newspaper of general circulation published within the District.
